The following is a general guideline for the care of well children who are growing and developing as expected. Also listed below is a schedule of immunizations as recommended by the American Academy of Pediatrics. The first year is a particularly busy time with at least 8 trips to the office. During that time, I suggest scheduling your next visit before leaving our office.



We are closed on Sundays as well as most State and Federal holidays. The office is also closed during lunch from 12:00 noon - 1pm.

We see children by appointment only. If your child is sick, he/she will typically be seen that day, but please call ahead for an appointment. We suggest you talk to the staff before requesting an appointment for a sick child. They may be able to advise you on how to treat your child at home, saving you time and the cost of an office visit. If you are unable to keep an appointment, please notify our office as soon as possible so we may use that time to care for another patient.

TELEPHONE PROTOCOL

During office hours, you can call for problems or questions regarding your child's health at (808) 487-1600. Calls are screened by the staff who have been trained to make decisions on which patients need to be seen and how to treat children that don't need to be seen. If they cannot help you or if you have further questions, I will call you back as soon as possible. If you would feel better having your child seen even though it may be minor, please let the medical assistants know.

Before calling the office to request a refill on daily medication, please check the box or bottle of medication and call the pharmacy to make sure you don't already have refills approved.

After office hours, calls should be made only for emergencies or urgent problems. Please do not abuse this free privilege by calling for something that could be handled during the day. After hours, please page me through the Physician's Exchange at (808) 524-2575.

EMERGENCIES

If the situation is critical, call 911. If you believe your child's situation is urgent, take your child to the nearest Emergency Room. **Before driving to the ER, call me first.** Often, I may be able to provide important first aid instructions by phone and direct decision making. I would prefer you to take your child to Kapiolani Medical Center ER since there are experienced and qualified pediatricians available 24 hours a day. If for any reason, you have difficulty reaching me, you may call the nearest emergency room for immediate advice (Kapiolani Medical Center: 983-8633)

For poisonings, call the **Hawaii Poison Center** at **1-800-222-1222**. Always check with the Poison Center before taking any action. There will be occasional times when I am either out of town or unavailable. I will make arrangements with other physicians in the area for the care of your child in my absence, and the office staff will be able to direct you to their offices.
